Based on that evaluation, The Corporation only recognizes the maximum benefit of each income tax position that is more than 50% likely of being sustained. To the extent that all or a portion of the benefits of an

income tax position are not recognized, a liability would be recognized for the unrecognized benefits, along with any interest and penalties that would result from disallowance of the position. Should any such penalties and interest be incurred, they would be recognized as operating expenses.

Based on the results of management's evaluation, no liability is recognized in the accompanying balance sheet for unrecognized income tax positions. Further, no interest or penalties have been accrued or charged to expense as of September 30, 2019 and 2018 or for the years then ended. The Corporation's tax returns are subject to possible examination by the taxing authorities. For federal income tax purposes, the tax returns essentially remain open for possible examination for a period of three years after the respective filing deadlines of those returns.

The community health needs of residents within Jasper County were identified through in-depth interviews with a broad range of advocates representing the interests of the community including public health representatives, community leaders, physicians, school health, and other health care providers. Input is gathered via face-to-face interviews and an on-line community survey.

Based on the collected interviews, expertise, and feedback from this group of advocates representing the interests of Jasper County and analysis of available health data a list of community health needs was developed. Each of the seven identified health needs have been evaluated and prioritized by input from key informants and the JMH leadership team.

Health needs were prioritized based upon the scope and severity of the issue. Each need was evaluated based upon the priority of the issue, the fit with the JMH mission, the ability to achieve improvement, and the availability of resources. Five of the seven identified health needs were selected for implementation.

Two identified health needs will not be addressed in the implementation plan. While transportation difficulties do impact access to care for a small percentage of the Jasper County population, non-emergent transportation falls outside the scope and mission of JMH. Due to resource constraints, JMH is unable to address this need at this time.

An individual's access to clinical care and treatment options, is impacted by economic constraints. JMH will continue to participate in Medicare, Medicaid, and other government programs. Efforts are made to educate our patient population about insurance coverage and payment options for their care. As part of its mission to the community, JMH provides discounted and free care based on federally set income levels.

(JHS), incorporated November 8, 1999, is a not-for-profit corporation whose primary purpose is to operate Jasper Memorial Hospital (JMH) (a 17-bed critical access hospital), Retreat Intermediate Care Home (a 55-bed skilled nursing facility) and the Primary Care Center for Monticello (PCC), a provider-based physician practice, located in Monticello, Georgia.

Pursuant to a lease and transfer agreement dated July 2, 1999, The Hospital Authority of Jasper County leased its facilities and transferred its operating assets, as defined in the agreement, to Oconee Regional Medical Center, Inc. (ORMC). In an assignment agreement dated January 1, 2000, the ORMC assigned the lease to Jasper Health Services, Inc.

On May 10, 2017, ORMC filed a voluntary petition for relief under Chapter 11 of the Bankruptcy Code in the United States Bankruptcy Court for the Middle District of Georgia. The bankruptcy proceedings were resolved on October 2, 2019. See below for additional information. At fiscal year-

end, JHS had not provided ORMC written notice to terminate the lease as required by the Articles of Incorporation in effect at September 30, 2019.

Form 990, Part III, Line 4a - First Accomplishment

Jasper Health Services, Inc. (JHS) exists to provide a continuum of healthcare for the residents of Jasper County. The facility is located in a rural area with limited economic opportunities but provides necessary medical care without regard to the ability to pay. The emergency department served 3,650 patients during the year with a significant portion uninsured and unable to pay for their care. There were an additional 3,055 outpatient encounters for diagnostic services and therapy. Approximately 99.65% of the 1,434 inpatient days were provided to persons covered under the Medicare or Medicaid related programs or had no insurance coverage at all. JHS operates a physician practice providing primary medical care with over 7,511 encounters during the year. JHS provides services with charges either reduced or eliminated based on the patient's income, giving discounted care for patients with up to 250% of the Federal Poverty Guidelines. JHS provided approximately \$2,857,000 in uncompensated care.

JHS had not provided ORMC written notice to terminate the lease as of September 30, 2019; however, Amended and Restated Articles of Incorporation were adopted on October 9, 2019 by written consent of the sole member of the Corporation, Oconee Regional Health System, Inc. (ORHS). Additionally, Amended and Restated Bylaws were approved and adopted by JHS Board of Directors on October 9, 2019.

Significant changes to the organizational governing documents effective October 9, 2019 include:

- JHS will have no members.
- Board members shall number between three and seven; the requirement for ORHS members is eliminated.
- ORHS will no longer have the authority to nominate/elect board members or approve any actions of the JHS board.
- The Hospital Authority of Jasper County, Georgia (Authority) will have the right to nominate one board member and at least one JHS board member shall be a member of the Authority.
- Amendments to the governing documents will no longer require the written approval of ORHS.

declared bankruptcy. As indicated above, ORHS no longer exists; however, the liquidating trustee has not yet released JHS from any restrictions associated with the prior lease agreement and governing documents. See discussion above for changes made effective October 9, 2020.

Form 990, Part VI, Line 7a - Election of Members and Their Rights

In the past, three members of the board nominated by the Hospital Authority of Jasper County, Georgia (Authority) required the approval of both JHS and ORHS. ORHS appointed four board members, two of which were the Oconee Regional Medical Center, Inc.'s (ORMC) CEO and the Chief-Elect of the Medical Staff. Any nominations to fill vacancies on the board are subject to prior written approval of the ORHS Board of Directors.

With the sale and dissolution of ORHS (including ORMC) effective September 30, 2017, the ORHS board members tendered their resignation. See discussion above for changes made effective October 9, 2020.

Certain actions of the JHS board required prior written approval of ORHS and include amending or restating the Articles of Incorporation or the Bylaws; appointing or removal of a director; entering into joint venture or partnership; adopting a plan of liquidation or dissolution; entering into sales, mortgage or disposition transaction of substantially all corporate assets; mergers or consolidations; annual operating and capital budgeting; amending or terminating the lease of the hospital facility. ORHS ceased to exist 9/30/17 and the liquidating trustee has not released JHS from these restrictions. See discussion above for changes made
